## Tuition Policies

1. All monies paid are NON-REFUNDABLE
a. unforeseen circumstances such as job transfers, terminal illness, \& job loss will be taken on a case-by-case basis. It will take at least 30 days to decide on the refund and process.
2. All payments are set up for Electronic Funds Transfer (EFT) and will be scheduled according to your instruction. Check and cash payment plans can be arranged for an additional fee of $\$ 50$.
3. Regardless of plan and start date: All tuition, fees and curriculum are to be paid in full by April 15th each year.
4. The weekly plan
a. A weekly payment plan is calculated on a 35 -week schedule.
b. All fees and tuition rolled into a weekly payment is for 35 weeks.
c. Drafts will be made from your account over the 2 weeks of Christmas break.
d. A $\$ 20$ late fee will be charged if a weekly EFT is declined.
5. The two-payment plan is available to those who can pay $\$ 3,600$ by March 28 or time of enrollment.
a. The second EFT of $\$ 3,600$ will be set up to draft on December 2, 2024.
b. A $\$ 50$ late fee will be charged to your account if your check or EFT is declined.
6. The one-payment plan is available to those who can pay $\$ 6,300$ by June 28 or at the time of enrollment.
a. A $\$ 100$ late fee will be charged to your account if your check or EFT is declined.
7. A full year of tuition, fees and curriculum will be charged for any student starting on or before Oct 21st.
a. Prorated charges will be calculated from the full tuition column for students who enroll after October 21.
b. A $\$ 500$ discount will be the maximum savings for one- time payments negotiated after October 21.

## 8. Sibling Discounts:

a. $10 \%$ will be applied to the total family tuition cost across the board on any plan.
b. There is no "mark up," therefore no sibling discount, on our curriculum, enrichments, or testing,
